- **Having regard to** the Constitution;
- **Having regard to** Decree No. 2021-0001/PRES of January 5<sup>th</sup>, 2021 appointing the Prime Minister;
- **Having regard to** Decree No. 2021-0002/PRES/PM of January 10<sup>th</sup>, 2021, relating to the composition of the government of Burkina Faso;
- **Having regard to** Decree No. 2016-753/PRES/PM/SGG-CM of February 1<sup>st</sup>, 2021, on the powers and duties of the members of the government;
- **Having regard to** Decree 2016-753/PRES/PM/MS of August 16<sup>th</sup>, 2016 relating to the structure and functions of the Ministry of Health;
- **Having regard to** Decree N°2020-0684/PRES/PM/PMCIA of August 10<sup>th</sup>, 2020 relating to the structure and functions of the Ministry of Trade, Industry and Handicrafts;
- **Having regard to** Zatu N°AN IV-039/CNR/CAPRO of June 18th, 1987 relating to the organization of the tobacco monopoly;
- **Having regard to** Law No. 040-2010/AN of November 25<sup>th</sup>, 2010, on Tobacco Control in Burkina Faso;
- **Having regard to** Decree No. 2011-1051/PRES/PM/MS/MEF of December 30<sup>th</sup>, 2011 relating to the packaging and labelling of tobacco products in Burkina Faso and its amendment;
- **Having regard to** the Joint Order N°2015-366/MS/MICA of April 7<sup>th</sup>, 2015 setting out enforcement modalities of Decree N°2011-1051/PRES/PM/MS/MEF of December 30<sup>th</sup>, 2011, on the packaging and labelling of tobacco products in Burkina Faso and its amendment:

#### **HEREBY DECIDE AS FOLLOWS:**

Article 1: This Order is issued pursuant to Article 6 of Decree No. 2019-0676/PRES/PM/MINEFID/MS/MCIA of June 26<sup>th</sup>, 2019 amending Decree No. 2011-1051/PRES/PM/MS/MEF of December 30<sup>th</sup>, 2011 on the packaging and labelling of tobacco products in Burkina Faso and Article 16 of Decree No.

It specifies, as part of the second set of warnings, images, texts, numbers, figures and any other information to be displayed on tobacco product packaging.

Article 2: Images and health warnings to be displayed on tobacco product packaging are included in the Annex.

Numbers, figures and any other information to be shown on the tobacco product packaging are those provided for by the joint Order No. 2015-366/MS/MICA of April 7<sup>th</sup>, 2015 and its subsequent amended joint Order No. 2019-0365/MS/MICA of October 8<sup>th</sup>, 2019, on the enforcement modalities of Decree No. 2011-1051/PRES/PM/MS/MEF of December 30<sup>th</sup>, 2011 concerning the packaging and labelling of tobacco products in Burkina Faso, and its subsequent amendment.

- Affixing images, texts, numbers, figures and other information on tobacco product packaging as provided for in Article 2 above shall be carried out in accordance with the requirements set out in the Joint Order No. 2019-0365/MS/MICA of October 8<sup>th</sup>, 2019 amending the Joint Order No. 2015-366/MS/MICA of April 7<sup>th</sup>, 2015, on enforcement modalities of Decree No. 2011-1051/PRES/PM/MS/MEF of December 30<sup>th</sup>, 2011 concerning the packaging and labelling of tobacco products in Burkina Faso.
- Article 4: Health warning images and texts specified in the first paragraph of Article 2 shall be valid for twenty-four (24) months. They shall be made mandatory upon expiry of the first set of health warnings.

The first image and the corresponding warning message will be used for the first twelve months. The second image and the corresponding warning message will be used for the subsequent twelve months.

Article 5: The Permanent Secretary of the Ministry of Health and the Permanent Secretary of the Ministry of Industry, Trade and Handicrafts, each in his respective capacity, shall be responsible for the enforcement of this Order, which shall take effect from the date of its signature and shall be registered, published and disseminated where necessary.
