

## **Related-Ministries-and-Agencies Coordinating Committee for Tobacco Countermeasures**

### 1. Purpose

Based on the World Health Organization Framework Convention on Tobacco Control, in close collaboration with relevant ministries and agencies, in order to promote tobacco countermeasures, the Related-Ministries-and-Agencies Coordinating Committee for Tobacco Countermeasures (hereinafter referred to as the "Coordinating Committee") will be established.

### 2. Members

The Secretariat (General Affairs) of the Coordinating Committee, in cooperation with the General Affairs Division of the Tobacco and Salt Industry Offices in the General Affairs Division, Financial Bureau, Ministry of Finance, will establish an office in the General Affairs Division, Health Service Bureau, Ministry of Health, Labour and Welfare, to establish policies on lifestyle diseases.

Necessary matters related to conducting meetings, etc., will be decided by the Coordinating Committee.
